The Department of Natural Resources can provide reviews for three key areas

- Environmental reviews: National Environmental Policy Act (NEPA)
- Cultural Reviews: National Historic Preservation Act Section 106
- Recreational Property Review: Land and Water Conservation Act Section 6(f)



Environmental reviews will consider land, water, air, and geological resource impacts

- Review is coordinated by the Director's Office
- Review is conducted by Missouri Geological Survey, Water Protection Program, Air Pollution Control Program, appropriate regional office, and Waste Management Program

Recreational property reviews will consider impacts to some parks and other recreational properties

- Contact DNR when you need to determine impacts on two kinds of public parks: Missouri's State Parks and parks protected by the Land and Water Conservation Fund (LWCF) Act
- Email a letter describing your project and potential impact to parks. Include a map, plans (if you have them), information about any interest in real property that must occur as part of the project (i.e. a new permanent easement or lease)
- Pro tip! LWCF protects can take many forms, including small city parks or playgrounds at public schools

Cultural resource reviews will consider above- and below-ground cultural resources

- Submit project info along with SHPO's Section 106 Project Information Form found on website: <u>MOSTATEPARKS.COM/SHPO</u>
- Very important details:
 - Provide good locational information (e.g., spatial coordinates, maps, etc.)
 - O Visual impacts on historic properties?
 - Nature of ground disturbance
 - Within previously disturbed utility corridors or undisturbed areas?
