






# Missouri is making progress on broadband, but there is a long way to go.

## August 5<sup>th</sup> Prioritization


### Accomplished:

# Using ARPA for Broadband: Other Tips

- Reporting requirements are significant. The U.S. Treasury has posted [compliance and reporting guidance](#) and [this guide](#) is particularly helpful.
- Make sure to track updated rules, FAQ's, and other guidance; seek legal or fiscal help in interpreting and implementing them as appropriate.
- Follow normal procurement and solicitation processes of your local government.
- Missouri State Treasurer has created a [Transparency Portal](#) that provides information on ARPA-related allocations, FAQs, and data on Missouri's COVID-related expenditures,
- Reach out to DED's Office of Broadband Development for additional broadband assistance when needed.
